4. Senate Speaker 8:37 PM

A. Andrew V. Abela, Dean of the Busch School of Business

Motion to temporarily suspend the Senate Bylaws by **Senator Kish**, seconded by **Senator Fritz.**

Voice vote on the suspension of the bylaws \rightarrow Passes unanimously

Rules suspended

Dean Abela rises to address the Senate. He discusses virtue as a means of making life easier, more enjoyable, and more purposeful. He talks about managing habits and how most people habitually manage their thoughts, actions, and emotions. Amidst the modern epidemic of anxiety and depression, habits of thoughts, actions, and emotions are virtues of human excellence. Aristotle says the virtuous life is the happy life, and virtue is a balance of awareness and action. Virtue is based on your understanding of the right thing to do, your follow through, and your reasoning for following through or not. Dean Abela states that if you're not growing in virtue, then your habits will not reflect it.

Senator Tucker asks if vice starts with unconscious incontinence, how does a person gain continence?

Dean Abela explains that people are rarely vicious, and it takes a good friend or a crisis to startle someone back to reality. He explains that when he had fallen away from his Catholic

faith, the character Jean Valjean from Les Miserables inspired him to draw nearer to God.

Senator Hermes asks what virtues are most important for a politician.

Dean Abela says that prudence or practicality are the most important for those involved in politics. It is not about making a show, but truly acting on virtue. Virtue is harder to set aside when it's convenient.

Senator Kish asks who Dean Abela's favorite Saint is.

Dean Abela says that some of his favorite saints include St. Thomas Aquinas, St. Maximilan Kolbe, and St. Margaret.

A. Committee Chair Updates 8:55 PM

i. Senator Holcomb, Rules and Administration

Senator Pausion speaks on behalf of **Senator Holcomb**, and says that he is working on finalizing dance students' access to athletic trainers. **Senator Mullin**'s Bill 003 will be discussed tonight. **Senator Paulson** and **Senator Salerno** are working on keycard access discrepancies. **Senator Paulson** is discussing a better collaboration between nursing and enrollment services.

ii. Senator Gehrig, Academic Affairs

Senator D'Albero, speaking on behalf of **Senator Gehrig**, says that **Senator Gehrig** has an upcoming meeting with CACS regarding a professional headshot booth. **Senator Raddell** is still working on civil dialogue in light of the upcoming fall election. **Senator D'Albero**'s resolution will hit the floor tonight.

iii. Senator Kish, University Services

Senator Kish says that Senator Norcross will not pursue his resolution regarding the Pryz music. Senator Crawford is working on several projects. Senators D'Attelo and Arreaga-Cacao are working with the parking department, and Senator D'Attelo is still working on his resolution regarding the ROTC scholarships.

iv. Senator Ewing, Student Resources

Senator Ewing states that Senator Henry is continuing to work on his bike racks resolution, Senators Tong and D'Albero are continuing to work on the Metro U-Pass resolution, and Senators Morris and Ewing are waiting for the implementation of their resolutions.

v. Senator Corey, Campus Life

Senator Corey says that the committee on Campus Life was unfortunately unable to meet this past week due to illness and the other commitments of its members. **Senator Lance** is still working on his energy efficiency resolution with Tim Carney. **Senator Hermes** has been reaching out to the campus dietician to further discuss his resolution for the Kane Fitness Center. **Senator Pereira-Ruano** has nothing new to report.

B. Senator D'Albero, School of Architecture and Planning (Resolution 015) 9:00 PM

i. A Resolution to Create a Facilities Incident Reporting System

President Harvey delivers a first reading of the resolution.

Senator D'Albero gives her opening remarks.

Senator D'Albero mentions that many students in the residence halls have experienced facilities staff not showing up to a scheduled time, failing to knock on doors, amidst other issues. **Senator D'Albero** realized it is a bigger problem than she originally thought and sought to find an appropriate solution alongside guidance from facilities and maintenance professional staff.

By meeting with facilities who were very receptive, she has found places where there is miscommunication. She is currently working with the facilities and maintenance services to create a reporting system for any issues students may encounter with maintenance requests. Both facilities and housing were clear that they want to fix the issues and provide more efficiency for students. They want to hear about incidents, encouraging students to report any issues.

Senator Hermes asks what type of reporting medium would be used. Would it be a google form?

Senator D'Albero responds that, at first, the idea was to have a google form, making sure there would not be any confusion between incident reports and actual facilities requests. Although the final product may not be a simple google form, Facilities and

Maintenance Operations will create a form online for students to submit comments or any feedback regarding the process.

C. Senator Molly Mullin, Class of 2024 (Bill 003) 9:30 PM

i. A Bill to Maintain Fair Campaigning in SGA Senate Elections

President Harvey delivers a first reading of Bill 003.

Senator Mullin rises to give her introductory remarks. She says the goal of this bill is to correct a small, yet critical oversight. There is currently no clause about write-in candidates needing to abide by the Senate Election Bylaws, which includes important campaigning rules such as the spending limit and poster approval. The absence of this clause risks a situation wherein write-in candidates are not held to the same standard as other candidates. **Bill 003** would remedy this situation. The loophole has not yet been taken, but it remains important to maintain the integrity of the Senate Election Bylaws to uphold smooth elections and democracy.

Senator Arreaga-Cacao says that the bill has his support as a write-in candidate himself, and it highlights a small yet critical issue.

Senator Tucker thanks Senator Mullin for bringing this issue to the attention of the Senate. He says that although he was a write-in candidate, he did not use the loophole. He asks if the bill would subject write-in candidates to all the rules regular candidates are subject to. Specifically, would write-in candidates be subject to the ballot statement clause despite not being on the

ballot? He asks if Senator Mullin would consider an amendment to address this inconsistency.

Senator Mullin thanks Senator Tucker for flagging the issue. She says she is open to an amendment.

Senator Tucker clarifies that the subsection in question is Subsection 13.

President Harvey affirms.

Senator Tucker submits an official amendment that states "...outlined in Article VII, Section 6, Clause 1, with the exception of subsection (xiii)."

Period of discussion follows.

Motion to vote on the amendment by **Senator D'Attelo**, seconded by **Senator Morris**.

Vote on the amendment \rightarrow Passes unanimously.

Amendment adopted.

Motion to vote on the bill from **Senator Kish**, seconded by **Senator Suarez**.
