### 1. Public Comment 8:20 PM

A. Public comment will be taken at the start of the session. Comments will be limited to one minute per person. Persons making comments will be asked to begin by stating their name for the record, and if applicable naming the college or organization they represent. **Jacob McCarthy**, a freshman, wanted to raise a quick awareness of Spookappella. He was excited to go see it, yet was left disappointed by the various sexual jokes he deemed unnecessary. More than that, there was religious paraphernalia used inappropriately, sexual jokes about the bishop, and comments attacking the clergy. It was painful to see here at Catholic University.

**Vice President Wallace** thanks Jacob for his comment, but would also like to note that today's agenda has nothing to do with Spookappella and because today's senate would be packed, she asks future public comment to refrain from speaking on things not related to today's agenda.

**Micheal Dane,** a double major in politics and communication, voices his support for Senator Martin's resolution to extend the Eatery hours. He communicates how many students support this, especially athletes.

**Senator Sharpe** makes a point of personal privilege and states that he is not aware of any bylaws that prevent the public from speaking out about anything other than the contents of the agenda.

**Vice President Wallace** appreciates the comment Senator Sharpe brought up. She speaks on her ability to restrict public comment.

# 4. Committee Reports 8:28 PM A. Senator Sharpe, Rules and Administration

**Senator Sharpe** has no updates. He mentions that a member of his committee, Senator Jagiello, is bringing a resolution to the floor that he supports and thinks it is great. There are some other resolutions in the works. There have been no major bylaw revisions, however if any senator had any suggestions, please go to him.

# B. Senator Schlee, Academic Affairs

Senator Schlee thanks President Wallace and is so happy to see all the support tonight for the resolutions from the public. Her committee is bringing three resolutions to the floor today, one being her resolution on Academic Dishonesty, Senator Crncovich's resolution on requiring Ex Corde Ecclesiae to LCs, and Senator Lackey's resolution on mental health days. Senator Lackey put in a lot of work and she is excited to see the resolution on the floor tonight. Senator Schlee also reminds the senate of a future resolution coming to the next Senate meeting is the CACS resolution. She reminds everyone to fill out the advising survey. Dean Smith from the school of Art and Science sent out the survey today. She urges all the senators from the different schools to encourage their constituents to please fill out this survey. She wants as many responses as possible. If any senator wished to, she would appreciate edits and comments on the working draft of the resolution. She is also excited for a fruitful debate tonight.

### C. Senator Besendorfer, University Services

**Senator Besendorfer** thanks Vice President Wallace. The committee was excited to meet and welcome their newest member, Senator Suarez, who is already working on her first resolution to improve lightning on campus. She is currently working on passing her next resolution for UPass. She plans to meet with DSA and the accountant of law school.

### D. Senator Farrell, Student Resources

**Senator Farrell** thanks Vice President Wallace. The committee had a productive meeting last week, as they went over both of Senator Martin's resolutions, one hitting the floor tonight. The committee also discussed the other resolution she plans to bring to the floor next meeting. They also discusses Senator Hermann's resolution to utilize the infrastructure put in for COVID-19

### E. Senator Birth, Campus Life

**Senator Birth** states that the committee did not meet in the past week, as this past week was not an off week for the senate, which is when they typically meet. However, at their last meeting, the committee talked about forthcoming resolutions, including meetings with DPS about the Rave Guardian app they have and evolving it a bit more for student usage. Senator Michels has a resolution in the works for Title IX as well.

### 4. New Business

# A. Senator Schlee, School of Arts and Sciences (Resolution 013) 8:32 PM i. A

Resolution to Better Outline the Academic Dishonesty Policy

Senator Schlee wants to explain the perspective from which this resolution came from. Not everyone is familiar with the entire process of the appeal. She has served on the academic dishonesty appeals committee of students accused of cheating. Her experiences serving made her concerned about a few issues about students not being protected. To start off, there were three professors, one grad student, and one undergraduate student. That is concerning because already it is favoring professors. She knew every student's name who appealed. She should not have. The professors knew the name as well. Everyone is innocent until proven guilty. If the professors have the student in their class they could be biased against them. Confidentiality is a huge issue. Last year there were several cases where the professor did not have a meeting with the student. That is the student's chance to defend themselves. You cannot defend yourself if you don't know what you are being accused of. Professors need to be made aware of the process of accusing a student. Academic dishonesty accusations were out of control last year, and there are still online classes. It is important to protect students and make the appeals process clearer for both students and professors.

**Senator Fahey** thanks her for bringing this to the floor. It is very comprehensive. She is wondering how Senator Schlee joined the committee.

**Senator Schlee** responds she did not join by choice. Dean Smith asked her to serve on the committee as a favor. The dean will ask a student they trust, someone who is invested. Hopefully this improves into something more protective of students of their future

**Senator Suarez** asks if this committee is per school or one committee for the university. **Senator Schlee** says that it is per school. None of the appeals she saw were out of the School of Arts and Science.

**Senator Pelekasis** thanks Senator Schlee and can see her passion for this. She asks if students who file the appeal attend the committee?

**Senator Senator** responds that students do not appear in front of the committee. If you are accused of cheating the professor will set up a conference and discuss why they think you cheated. They will ask you questions and if they still believe you cheated, they send that information to the dean. If you didn't cheat, you can appeal in written form and provide evidence. It can be your

work, so for example a piece of paper with math questions worked out. Students don't appear for confidentiality reasons. There should be no identifying information. You shouldn't know who that person is, so there isn't any bias. You shouldn't make a decision based on who the person is. It can lead to a taiend view of them in the future.

**Senator Jagiello** appreciates the effort and believes it is a good resolution. However, professors should know if there were past instances where the students cheated and so should the committee.

**Senator Schlee** says there is a misunderstanding. It is not redacted if they have a history of cheating. If they are a repeated offender, they will have a more severe penalty. If they are appealing, you will see that. We are not letting students off the hook here, academic integrity is still extremely important. This is just making sure students are aware of their rights and professors are aware of the process they must follow.

# B. Senator Jagiello, School of Architecture (Resolution 014) 8:49 PM i. A

Resolution to Place Crucifixes in the Crough Center

**Senator Jagiello** thanks Vice President Wallace. He wants to keep this short and simple. In the Arcitucheur building, there are no crucifixes other than in a corner in the printer lab. There are a lot of places to put a crucifix. When he was at the homecoming dance, he noticed that the Law School atrium did not have a crucifix either. Why do we not have the central thing we should be focusing on?

**Senator Kwiatek** thanks Senator Jagiello for bringing this to the floor. She is in full support, as it is imperative to have a crucifix. She wants to know where in Crough the crucifixes would be installed.

**Senator Jagiello** says there should be one when you first walk in in the main lobby. The auditorium used to have one, but it is gone now. There should also be crucifixes in the studio stations.

**Senator Schlee** thanks Senator Jagiello and congratulates him on bringing his first resolution to the floor. She appreciates what he is saying and agrees. She is curious why the law school was added. It is a separate section and we do not have control over this, as it is a separate entity. She asks if he has talked to anyone at the law school and if he would be open to an amendment.

**Senator Jagiello** says that the fact that the Columbus School of Law is a building on our campus is enough. It is owned and operated by CUA. Instead of an amendment to remove the law school, he would be open to an amendment to add it.

The title now reads A Resolution to Place Crucifixes in the Crough Center and Columbus School of Law

**Senator Kazanci** has lots of respect for Senator Jagiello but can no longer be in support. Over the past week, a lot of her constituents came to her and voiced their concerns about crucifixes in Crough. The architecture school is very old, and if students wanted this it would've happened already. This would be pushing beliefs on them that they don't agree with.

**Senator Moore** thanks her for her concern. This resolution is trying to bring Crough in line with the rest of the school. This is in line with our faith and does fall under our mission. The precedent of having crucifixes is already set all over campus.

**Senator Sharpe** says that the catholic mission requires us to welcome us of all faiths. 85% of the community is catholic. When students come here, they should expect to see symbols of our faith. He questions the concern, seeing as it is the Catholic University of America. He can't see why students are surprised or concerned. This is something that is fundamental to our faith.

**Senator Scott** says that the concern of people being uncomfortable is a good concern to have. At the same time, we are the Catholic University of America. The crucifix is a fundamental symbol of our faith. It is not forcing religion on people, because at the end it is an image. It is an image for those who do believe, and reminds them of their faith. If people are uncomfortable with crucifixes, then he doesn't believe this is the right university for them. There is a huge shrine on campus, not to mention the name of the university. There is a crucifix in this room, which you don't notice unless you look for it. What Senator Jagiello is asking for is not very intrusive at all. This is perfectly reasonable for a crucifix in a general area. It is very prevalent in our faith.

**Senator Jagiello** says that the gym used to be used for graduations and masses. He finds it appropriate to show some catholic faith. It is a nice reminder in the studio spaces that we are using our talents and gifts to serve Him. This is the Catholic University of America, and it is not away from the rest of the campus. It is a three floor building, yet there is only one crucifix in the whole place.

**Senator Birth** has no concerns with the resolution, but is deeply concerned over the langues some senators are using. We should be mindful in our langues about who should and shouldn't come to campus and we are elected officials and should act accordingly.

**Senator Scott** agrees with Senator Birth. We as senators must be careful of what we say. It seems to him that if someone has an intense discomfort with the symbol of the crucifix and comes here, there is a bit of disconnect. If you are afraid of bears, you don't say lemme go to the house of bears. I do not like lions, so I won't be walking into the lion's den.

**Senator Cunningham** comments that it is not our place to make comments on students and mock them about discomfort. He has a three part question. How many rooms do you want them in? What size, shape, and model will they be? And has he talked to anyone?

**Senator Jagiello** responds that there are ten rooms in the buildings, four studios, and a mezzanine. The size and model does not matter, there is not need for them to be crazy elaborate. The architecture students could even design it themselves. He apologies for his comment. Everyone is welcome. We are the only school in the USA founded by the Bishops. We are the pinnacle of Catholic education. We welcome everyone, and should not be afraid to show our religion,

**Senator Besendorfer** thanks Senator Jagiello for bringing this to the floor and can see how passionate he is. She wants to know if he had met with someone from the law school. When she was working on her UPass resolution, she met with the law and grad school. She is not against the law school being put in, but wants to know if this is something that they are open to.

**Senator Sharpe** says that this body covers undergrad students, the law school is a grad school. So why are we addressing this out of our jurisdiction? For him, we have undergraduate professors in the law school, events, office hours, and more. This amounts to a recommendation. The executive can reach out to the law school. T

**Senator Surez** wants to express her full support because this is a part of our identity as a catholic university. It is something we should do, and something potentially for students, especially in times of stress. It is a wonderful idea.

**Senator Kazanci** says this may sound weird, but a lot of people don't go to the architecture school for catholic values, but architecture itself. While she will be voting no, she personally agrees with it. She has to represent her constituents, so she cannot fully support the resolution.

**Senator Sharpe** says it seems to him that if anyone here does not want to support crucifixes in one building, then why not take down all the other crucifixes? It doesn't make sense. Crucifixes should be everywhere. It is in our university mission to do so.

**Senator Moore** says that as an elected representative we should uphold the university mission. He doesn't see another resolution that upholds the university mission quite like this one. The crucifix is the central message of faith. This could bring the Crough to be fully integrated into the university as a whole.

**Senator Crnkovich** wants to address Senator Kazanci's point. It is a valid concern. The Architure school is very prestigious, a true gem of Catholic. One aspect of it is to preserve the classical culture and you can see that throughout Crough. The presence of the crucifix can reinforce the faith. That same faith that went in hand with classical architecture.

**Senator Jagiello** thanks Senator Crn. When he first came to Catholic, he came in just for the architecture school. He could care less if it was Catholic or not. Regardless of how you feel, it is important to have crucifixes.

**Senator Cunningham** has a two part question and possible comment. He wants to know who Senator Jagiello asked to put up the crucifixes and if it was possible to amend or make sure to address the concerts of students.

**Senator Jagiello** says he talked to Dean Ferguson and they can coordinate getting the architecture students involved with the implementation of crucifixes. If they 3D print it or use the woodshop, the costs would be very minimal. There could even be a crucifix design competition where each student could design their own crucifix.

**Senator Farrell** is in full support, but for the third time needs to ask him if he has meet with anyone at the law school

**Senator Jagiello** says he has not, but as Senator Sharpe said, the undergraduate body has enough of a presence where it should be brought to attention.

**Senator Besendorfer** has one more question. There seems to be extensive planning for the Crough, but what about the law school? Will it be #D printed? What is the size and cost? Would it be able to be put up?

**Senator Jagiello** says that there are no specifics about small details, just putting one up. There are plenty of places to put one up, but the bottom line is that one should be put up.

**Senator Moore** emphasizes that, like mentioned before, it would be a recommendation for the law school. Crough is more specific, and the law school gets more leeway.

**Senator Besendorfer** would like for this to go back to committee. She likes the idea of having the law school included, but would like to have a meeting with the law school first. There are lots of quirks, and it would be easier to implement if they talked beforehand. She brings up making a new resolution without the law school.

**Senator Jagiello** does not think this needs to be put in committee. This is as simple as putting a nail and piece of wood in the wall.

**Senator Sharpe** says that occasionally they have been asked to meet, but it is nor a requirement. He made a resolution about the university's endowment without meeting with them. A lot of big resolutions such a porn and allies were made without a meeting. There is no need to backlog over a small detail.

**Senator Schlee** thanks everyone for their concerns. She wants to clarify what Senator Sharpe said. It is a standard that senate likes to hold to try to meet when you can. Senator Sharpe knows the dean personally, it is a good norm to try to meet and makes it more legitimate. She is against having this go to committee. There are a lot of great ideas to keep it cost effective. In the future she suggests meeting with the administration.

**Senator Holcomb** still believes that it is our job to foster and meet with everyone. She thinks it is a great idea and the Rome school has crucifixes in the rehearsal halls and classrooms. It is important to meet with everyone and support sending this back to the committee. If not, he will be voting no.

**Senator Jagiello** says that there is a crucifix in the Pryz, and that it is not an academic building. There is no dean or administration for the Pryz. We do not need to take committee time to talk about something as simple as this. It is putting a crucifix on the wall. The committee has more

important things to worry about.

**Senator Holcomb** responds that when resolutions involve the Pryz, there are meetings with people. It is important to foster connections, and do not want to overstep.

**Senator Sharpe** says that tens and tens of resolutions were successfully passed that did not have meetings and were not perceived as overstepping. This is a recommendation, it is not a concern, as the law school will receive this very well. We are asking them to do something most fundamental to our faith.

# C. Senator Lackey, School of Nursing (Resolution 015) 9:33 PM i. A Resolution to

Include Mental Health Days in the University Academic Calendar Motion to extend meeting by

Senator Moore and seconded by Senator Farrell Motion passes

**Senator Lackey** started by thanking who supported this resolution, including the research committee. This is very close to her heart. Everyone who knew her in highschool, knew she studied hard and was a good student. She was very active in her parish. When she got to college, she kept up the same routine, sailing through the days. What everyone didn't see was that she had no other choice. There were voices in her head telling her she was going to fail. She spent every minute praying. She thought this was normal until she went to confession with Father Jude. She said forgive me father for I have not gone to confession in two days. He told her she had OCD and to go to the counseling center. Mental health days are only implemented only after an increase in student suicide. In Senate 6, Senator Hermann asked for these days and everyone agreed with her. Catholic has never had a suicide, but we should not wait utnil then to give students the support they need. There should be screenings and support as well as information as to what an intake session looks like. Mental health days allow students to get the help they need. It was an overwhelming feeling of relief and joy when she no longer had to keep living the way she was. Mental health days can help people who do not suffer help their friends recognize the day. This will not solve the mental health crisis in one motion, but it opens the door for the implementation for more. We are humans first and students second. She humbly implore everyone in the senate vote in favor.

**Senator Holcomb** thinks that it is very brave of Senator Lackey to share her experiences and appreciates it. She makes an excellent argument. We are all in the same boat here. At the beginning of the year, her dance professor told them to take a mental health day whenever they needed to. It is our professional responsibility to take care of ourselves, and not just in the performing arts. She hopes everyone has professors who do that too. It is a big thing and she urges everyone to vote in

favor.

**Senator Pelekasis** thanks her for bringing this resolution to the floor. It is evident that they are both very passionate about this issue. However, she has some questions about the mental health days. Will they be decided by the individual? How many days will they be? Will they be decided by the university as a whole or seach school? Will professors receive mental health days? Will this affect the school days or breaks or snow days? How are other universities implementing this?

**Senator Lackey** says that right now it would be one day per semester, preferably after midterms. Midterms are very tough and the break is well deserved. It would not affect any breaks or snow days. Other universities get fall break after midterms and we don't. The break is not the solution, we need something more. It would be once per semester, half way through, and across all academic schools. her original idea was each school would get to choose a day, but since students take classes in multiple schools, that wouldn't make sense. The best way for all students would for it to be on the academic calendar. This is the best way to start a conversation. She is excited to see how this can be implemented and about addressing burnout culture. Your esteem should not be about how stressed you are. You are allowed to take care of yourself and be a person. This is the time to start taking care of yourself and installing that in students.

**Senator Schlee** asks how many have heard from themselves or friends that they just need to make it to Thanksgiving or to Christmas. That says a lot. If we could all have a moment for ourselves and take a breath, it would be really beneficial. This will be a day for professors as well as students. We also have professors who are struggling as there is lots of stress for them as well. This will be for the greater good. If you yourself have not experienced a mental health crisis emergency, several of your friends have. It does not just impact the person, but everyone around them. We cannot let this happen. There has been a lot of research done and the research committee has been amazing. They figured out the best way to address this and it was the best version they could come to. She urges everyone to vote in support.

**Senator Hermann** says if anyone is on the fence there was lots of extensive research. This is not a new idea, they are just asking the school to better implement it. She urges everyone to vote in favor.

**Senator Suarez** thanks Senator Lackey for introducing this to the floor. This personally affects her and her peers. She asks how this would work around the counseling center being constantly packed.

**Senator Lackey** has a working theory in her brain. Like a snow day the university would be closed, but the counseling center can come and help. This would allow students to meet them and see that they are real people. Normal advocacy could resume the next day. This would allow wiggle room for advocacy to get it implemented.

**Senator Hermann** says that the counseling center has a lot of group sessions that most students don't know about and they could advertise that.

**Senator Birth** is thankful that there are a lot of mental health resources in DC. The first step is recognizing that you need help in the first place. As a Catholic, there is always that issue with faith and mental health cannot co-exist. If we took this step, all of the other universities could follow

suit. We also can grow the counseling center.

**Senator Martin** thanks Senator Lackey for bringing this to the floor. She is incredible for sharing this and it takes a lot of courage. She wants to know if she has spoken to anyone about how it would be implemented and it is not just an administrative day. It would be silly to have classe two days in a row, like Columbus Day.

**Senator Lackey** admits that she hasn't talked to the counseling center. She has reached out, but they are hard to get in touch with. She hasn't spoken with the administration either. This is already implemented, it would just be in a more structured way. It wouldn't be announced in the morning like a snow day, but it would be a day on the calendar. Just like the Immaculate Conception and Columbus day, it would be worked around and it is something that needs to be prioritized.

**Senator Schlee** asks if anyone has noticed that there wasn't a reading day this semester. It is usually on a Monday, but it was on a Sunday this year, which defeats the purpose of it. They have the ability to look at schedules ahead of time, and pick any day. It doesn't have to be a Monday, it could be a Friday or Thursday. They are leaving it open to accommodate for the best day to schedule it. They are going in the direction that makes the most sense. A snow day is not the same as a whole educational day where we can promote good healthy days on campus. This is something that is realistic and can stop the stigma around mental health.

We could get Father Jude and campus ministry involved to show that mental health is not a sin. He is in full support of this resolution.

**Senator Jagiello** loves this resolution and thanks Senator Lackey for bringing it to the floor. He personally resonates with the need to have a day off. As Senator Birth mentioned, the spitail connection is so prevalent, especially with what we all just went through. It is All Saints Day, let's pass this resolution. Getting to pray has a positive impact. This could be a day where the entire university can celebrate themselves. Making campus ministry more available is important.

**Senator Senator** thinks that the dining experience is a huge part of that transition into college. She came to college under unique circumstances, and wishes she had that experience last year. It is a great way to make friends, Extending the dining hours would mend and branch those other parts of campus together. This was the single biggest issue brought to her attention. There is an inaccessibility of not even food, but hot food.

i. A Resolution to Implement Ex Corde Ecclesiae in the Theology Learning Community Class
