# A Resolution to Increase Flexibility for Students With Only Two Theology Requirements

#### Whereas,

Many students in schools such as Architecture<sup>1</sup>, Engineering<sup>2</sup>, Music<sup>3</sup> and Nursing<sup>4</sup> are only required to take two courses in Theology and Religious Studies (TRS) to fulfill their distribution requirements.

# Whereas,

Those two classes, and the only options for those students, are Foundations of Theology I: Scripture and Jesus Christ (TRS 201) and The Church and the Human Person (TRS 202).

#### Whereas,

Students in other majors have to take three TRS courses to fulfill their requirements, with the third class choice left to the discretion of the student.

# Whereas,

This third option allows students to explore TRS classes which are of interest to them or better suit their areas of study.

# Whereas,

Extending broadened opportunities for students with only two required TRS courses would expose them to more diverse TRS course offerings which they would not otherwise have time or ability to explore.

# Whereas,

Other universities such as Loyola University Maryland,<sup>5</sup> Georgetown University<sup>6</sup>, Thomas Moore University<sup>7</sup>, Notre Dame University<sup>8</sup> and Villanova University<sup>9</sup> allow for more choices in the selection of theology requirements.

- 2. The Core Curriculum Outline Page, and all academic pages for each of the academic schools, such as Architecture, Engineering, Music and Nursing, be updated to accurately publicize the number and type of courses required for all students' theology requirements.
